#### Who We Are

Making a significant contribution to education in Scotland, the Scottish Council of Independent Schools (SCIS) is an educational charity representing and promoting the interests of more than 70 independent schools across the country. The sector provides a setting and educational offer to suit the needs of almost 30,000 pupils from a range of backgrounds and 82 countries, offering modern facilities and the latest in technology. Our schools are at the forefront of the digital revolution, ensuring pupils are equipped for the modern workplace.

SCIS promotes choice, diversity and excellence in our schools and across education. At its heart, the independent sector has always opened its doors to children from all backgrounds.

Our schools are taking a pro-active approach to ensure bursary support is directed towards those in genuine need of support. Currently, there are 3,000 pupils in this position benefiting from the opportunity to attend an independent day or boarding school. Our primary role is promoting advancing and supporting education within Scotland, in partnership with others where appropriate, as well as keeping independent schools abreast of educational developments, training opportunities and legislative change.

We take on multiple roles representing the sector by providing authoritative research and intelligence about the sector to policymakers, making an active contribution to curriculum development, the training of teachers and the development of teaching skills. For example, many teachers in independent senior schools work as markers for the SQA public exam system. In these and other ways, the independent school sector in Scotland shares its experience and expertise, to advance education across the country. This is underpinned by our representation on a range of public bodies and groups, including the SQA Advisory Board, Education Scotland and the General Teaching Council for Scotland.

#### **Our Aims**

- To advance education via curriculum development and the training of teachers
- To communicate and negotiate with the Scottish Parliament, the Government, and public and private bodies on behalf of the independent sector
- To contribute positively to the Scottish education system and work in partnership with state schools for the benefit of all pupils
- To advise member schools and their governing bodies on educational developments and legislation affecting independent schools (e.g. education, taxation, welfare, health and safety).

### The Role

The role of SCIS Chair is to be an ambassador for the independent school sector in Scotland. The Chair will be expected to be visible and highly credible with SCIS members, and their main stakeholders.

In this role you will work closely with the Chief Executive Officer (CEO) to ensure the smooth operation and proper governance of the Scottish Council of Independent Schools (SCIS). You will take the lead with the CEO in setting the strategy and identifying the key objectives for the organisation to ensure it continues to play a leading role in the education sector in Scotland.

#### In this role you will:

- Chair the full SCIS Board meetings plus any additional meetings that may be arranged from time to time
- Ensure proper and efficient conduct of Board Meetings and work with the CEO in setting agendas
- Chair the online AGM
- Take the lead with the CEO on the recruitment of Board Members and their induction by finding trustees/directors most suitable to help SCIS achieve its objectives, ensure diversity and provide for Chair succession
- Have overall responsibility for governance alongside the CEO
- Work with the CEO on giving direction to SCIS policy making, encourage discussion on setting strategy and the setting of priorities
- Communicate regularly with the CEO to discuss strategy, staff performance and wellbeing
- Attend the SCIS Annual Conference.

#### About you:

- Have experience of being a board director, possibly as a Chair
- Possess clear values and be values-driven
- Be a compelling and clear communicator
- Have a positive approach and outlook
- Have a genuine interest and passion in connecting
- Have wide educational experience
- Have an understanding of Scottish politics and culture
- Have an understanding of the breadth of membership, and the meaning of independence in the context of SCIS

- Be available to meet/communicate with the CEO as and when required
- As SCIS is a charity, having proven governance within the charitable sector would be advantageous.

#### Background:

- The successful applicant is unlikely to be a current school bursar, head teacher or serving school governor as our trustees/directors have to be drawn from these backgrounds
- Could have been a school governor or education leader in the past.
